AMOUNT REQUESTED:	£2,090	Match Funds:	None
Project Name & Cost	Positive Activities for Children & Young People £2,090		
Summary:	Callon Kids Community Club will deliver 20 weeks of positive diversionary activities (covering the summer holidays) to Children and Young People who are at the risk of becoming involved in criminal activity. Activities include football and swimming.		
Comments:	The project is being delivered in Preston's most disadvantaged wards; Fishwick, St Mathews and Ribbleton.		
Recommendation:	1. That this application is supported by the Commissioner. 2. That a grant of £2,090 is provided to Callon Kids Community Club.		

2. NAME:	Friends of Cavendish Road Recreational Gardens

Project Name & Cost	Park / Admiral Gardens Palisade Fencing £5,761		
Summary:	Cavendish Road Garden has been targeted to ASB and vandalism which is affecting the local residents and community. Friends of Cavendish Road Recreational Gardens wish to purchase and install a fence round the west side of the park which has been damaged by youngsters.		
Comments:	The group are working in partnership with the Council, Police and Fire Service to tackle the issue.		
Recommendation:	1. That this application is supported by the Commissioner. 2. That a grant of £2,500 is provided to Friends of Cavendish Road Recreational Gardens.		

3. NAME:	Jinnah Development Trust Ltd

Project Name & Cost	Youth in Action £2,270		
Summary:	Jinnah Development Trust will deliver a range of recreational and sporting activities to young people over a 5 month period. Jinnah Development Trust are working with the Local Policing Team to identify vulnerable youngsters at the risk of offending.		
Comments:	The group have undertaken a consultation with young people who state there is very 'little to do' in the area and no space for them to socialise in the evenings.		
Recommendation:	1. That this application is supported by the Commissioner. 2. That a grant of £2,270 is provided to the Jinnah Development Trust Ltd.

Summary:	Streetwise Youth Group will provide a programme of diversionary activities to Young People throughout the summer holidays. Activities include; Media, music, street dance, box fit, arts and craft and many more.		
Recommendation:	1. That this application is supported by the Commissioner. 2. That a grant of £2,500 is provided to Streetwise Youth Group <u>conditional</u> they submit their constitution and accounts.

Project Name & Cost	Springhill Community ASB reduction project £2,500		
Summary:	Springhill Community Centre has been a victim of ASB and criminal damage with youngsters climbing on the roof, using threatening behaviour and throwing slate. Springhill Community Centre would like to purchase and install CCTV, lighting and a roller barrier for the roof.		
Comments:	Springhill Community Centre is a popular community hub used by members of the public for various activities, ranging from BME Groups, womens groups and afterschool clubs.		
Recommendation:	1. That this application is supported by the Commissioner. 2. That the Commissioner provides funding for the preventative and security measures. 3. That the Commissioner does not provided funding for the planning application fee to Hyndburn Borough Council.

Details:	Lancashire Youth Challenge would like to provide 50 young people with the opportunity of a 36 week training course which includes; physical fitness, swimming lessons and nutritional understanding. Following the 36 week programme Lancashire Youth Challenge would shortlist participants from 50 to 20 who will go on to complete the canoeing challenge.
