Details:	1 st West Craven Scouts Group provides a meeting place and activities for boys and girls aged between 6 and 14 years. The building they meet in is in a 'dilapidated state and very cold' and the group has raised funds to cover the costs of a new boiler and central heating system. They would like to purchase and install windows and doors to help keep the heat in the building.		
Recommendation:	That this application is NOT supported by the Commissioner. That it is noted that the project does not clearly support the Commissioner's priorities.

Details:	Community Solutions North West would like to work and engage with isolated or vulnerable victims of crime through a new cycling group.			
Recommendation:	That this application is NOT supported by the Commissioner. That it is noted that Community Solutions North West have received funding from another one of the Commissioner's funding streams and are therefore not eligible to apply.
